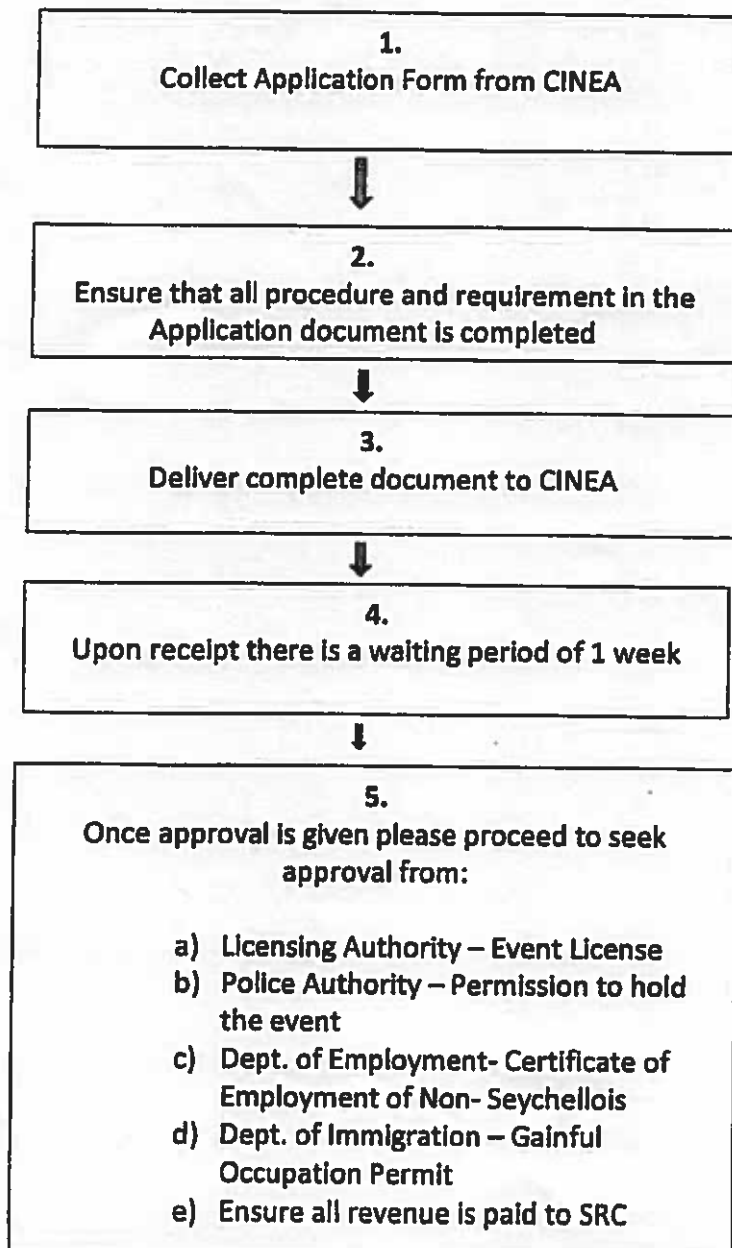


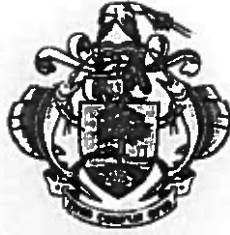

**Part B - Events Details (provide on separate sheet):**

1. Contract between the organizer and the participant
2. Artist Background  
Curriculum Vitae
3. A concise outline of the artist, group or individual, history emphasizing particular achievement (i.e. awards, honors, or performance at particular notable venues.
4. Itineraries in Seychelles
5. Police record of all members of group
6. List of all songs including Lyrics to be performed while in Seychelles.
7. Duration of performance and location.
8. List of all members of the delegation.
9. Copy of passport biological data page for all members of delegation.

**Part C – Assessment Procedure**

Following receipt of the application, the proposal will be considered by CINEA. The applicant will be then informed of the decision to support or decline the submitted project.

Applicants should allow a period of around 1 week between the submission of the application and subsequent decisions, as substantial consultations are required prior to a decision being taken.

Once the Application has (in principle) been approved, you will then proceed to obtain the approval of:

1. Licensing Authority
2. Police authority
3. Immigration permission
4. GOP for all participant
5. Payment of taxes due to Seychelles Revenue Commission
6. Repertoire of copy of all music to be performed delivered at SAC's Office.


